I/we hereby apply for vendor space in the Nyssa Chamber of Commerce and Agriculture's "Thunderegg Days Festival" (hereinafter "event") to be held at the Nyssa School Grounds on the above-referenced date. I/we agree to adhere to all terms and conditions of the event set forth by the Thunderegg Days Committee and Chamber Board.

Lawn Spaces: The vendor fees for the 2012 event are \$37.50 for a 15 foot space and \$75.00 for a 30 foot space. If your display is over 30 feet, you will be required to rent two (2) spaces. It is understood the vendor fee in full must accompany this application. Applications are accepted on a first come basis.

Food Court: Vendor fees for the food court are \$75.00 per space.

POWER—Power is available on a limited first come-first serve basis for an additional \$25.00. Due to the distance to our power source, not all lawn spaces have access to power. Food court spaces have access to power.

Yes, I'd like power if available.

SET UP—Set up will be Wednesday, July 11 on the school grounds. If you arrive before Wednesday morning, you need to park at Simpson's RV Park (Columbia Avenue & Highway 201, one mile north of town). The school grounds will be open to allow vehicles on the lawns beginning at 8 a.m. It is understood that no one is allowed on the lawn until directed to proceed by the Thunderegg Chairperson, or designated individual.

TAKE DOWN—No vehicles are allowed access to the lawn once the event begins. Take down loading can begin at 9:30 p.m. Saturday evening.

EVENT HOURS—I/we understand that the event is open Thursday through Saturday. As a vendor, I agree to have my display open from 10 a.m. to 9 p.m. Thursday through Saturday. If I fail to remain open during these hours, I may be asked to leave the event.

DISPLAY REQUIREMENTS—We reserve the right to remove any items, signs or people who demonstrate poor taste or conduct at the event. NO items related to alcohol, tobacco, weapons, or nudity can be sold during the event. If the Thunderegg Committee or Chamber Board reviews your display and you do not meet the requirements, it is understood that you may be asked to alter your display or leave the show.

GENERAL CONSIDERATIONS AND RESTRICTIONS—

- The Nyssa Chamber of Commerce and Agriculture will not be responsible for loss or of damage to any vendors' items, or vehicles.
- Dogs must be on a leash at all times; you must clean up after your dog each time.
- Generators may not run between 10 p.m. and 6 a.m. Use of generators during the day is discouraged. If you must use a generator, please limit the usage. Be considerate of your neighbor.
- No one may sell items on the school grounds during the event without a valid signed contract. Please do not support any solicitors who come to the show without a valid contract.

CANCELLATIONS—If you cancel before June 1, 2012, you will receive a refund of \$45.00 per 30' space (\$22.50 per 15' space). After June 1, 2012 there will be no refund.

LATE REGISTRATIONS—All registrations must be paid in full by June 1, unless prior arrangements have been made. This deadline can be extended up to 10 days, if payment is not received within that time frame, the space would no longer be reserved.
